

Gifts of Stock and Securities

Thank you for considering a gift of securities to International Christian Concern.
Your generosity helps ICC serve and support persecuted Christians around the world.
The instructions below explain how to transfer publicly traded securities electronically to ICC.

Before initiating your gift

Please ask your broker to confirm the transfer requirements. Brokerage transfers do not always include the donor's identity, so please also send ICC the completed donor notification form on page 2. This helps ICC identify, designate, and acknowledge your gift promptly.

Complete the transfer in three steps

1	Complete the donor notification form Fill out page 2 with your contact information, security details, expected transfer date, and gift designation.
2	Give the instructions to your broker Ask your broker or financial advisor to initiate the electronic transfer using ICC's verified brokerage information below.
3	Send a copy of the form to ICC Email the completed form to ICC@persecution.org or mail it to the address in the footer. Keep a copy for your records.

Do not include your personal brokerage account number, Social Security number, password, or login credentials on this form.

Gift date, valuation, and acknowledgment

For ICC's internal accounting purposes, the gift will be recorded based on the fair market value of the securities on the date received. After ICC receives the securities and sufficient donor information, ICC will provide a written acknowledgment describing the securities received. The donor is responsible for determining the amount of any charitable deduction and should consult a qualified tax advisor regarding valuation, substantiation, and individual circumstances.

Please send a completed copy to ICC after initiating the transfer with your broker. This form notifies ICC of your intended gift; it does not itself direct or authorize the transfer.
